**WAIVER OF LIABILITY AND INFORMED CONSENT RELEASE**

By signing this agreement you are certifying that, as a condition of your participation in an Outbound Hounds ("OBH") Group Class, you have been informed of and agree to the following:

**Acknowledgment of Risk:** I certify that I have been informed and understand that there is always some unavoidable risk of injury involved when working with animals, especially animals with behavioral issues. I acknowledge that dogs can be inherently difficult to control and that not all dogs in a Group Class will be under control at all times resulting in the possibility of injury, death, or property damage from disease, stray dogs, running away, other dogs in training, or other animals to myself, my dog, my family members, or third parties. Additionally, I have had full opportunity to discuss all concerns I have about the foregoing risks with Outbound Hounds' Heather Gutshall. I have also made all inquiries and investigations to my satisfaction related to such risks.

**Assumption of Risk:** I hereby accept and assume, without reservation, all risks associated with my participation in a Group Class, including, but not limited to: the risks of any and all injuries to myself, my dog and any of my family members or third parties who may attend; the risks that my dog may cause injury to other persons and/or dogs involved in the Classes; and the risks that saliva, water, food, snow and/or other debris may be present in the training area. I agree that if my dog causes property damage, or bites or injures any dog, animal or person during or any time after the date of this agreement, I agree to assume full responsibility and liability for any injury, death or property damage, and I agree to pay all resulting losses and damages suffered or incurred, and to defend, indemnify, and hold harmless OBH from any and all resulting claims, demands, lawsuits, losses, costs of expenses, including attorney's fees.

**Waiver, Release, and Indemnification:** As lawful consideration for participating in the Group Class, I, for myself, my heirs, executors, administrators, legal representatives, successors and assigns, hereby waive, release, discharge and agree not to sue and to indemnify, defend and hold harmless OBH, its employees, volunteers, agents, affiliates, and all others working on OBH's behalf, from any and all injuries, losses, claims and damages to any person or persons of any nature whatsoever, including claims arising from OBH's own negligence, and all costs associated therewith, including attorney's fees, court costs and consultant fees, arising from my participation in any OBH Group Class.

**Photographic and Media Release:** I hereby consent to myself or my dog being the subject of the photographs and/or audiovisual recording and authorize OBH to cause the same to be exhibited for promotional and/or educational purposes as still photographs, transparencies, motion pictures, television, video, social media marketing or other similar media. I hereby release OBH from any and all claims for damages for libel, slander, invasion of privacy or any other claim based on use of the above-described material(s).

I certify that I am the legal owner or guardian of any dog with which I participate in any OBH Group Class, and acknowledge that OBH is not responsible for confirming that I have legal ownership of said dogs. I have read the foregoing agreement and understand its contents. I consent to all terms and conditions set forth above.
